



## URBAN MEDIA ARTS (UMA) PARENT/GUARDIAN PERMISSION

URBAN MEDIA ARTS (UMA) REQUIRES PARENT/GUARDIAN PERMISSION FOR ANYONE UNDER THE AGE OF 18 WORKING INDEPENDENTLY OR IN A GROUP SETTING ON AN UMA PROJECT IN A MEMBER OR VOLUNTEER CAPACITY. YOUTH MEMBERS/VOLUNTEERS MUST HAVE A CURRENT PARENT/GUARDIAN PERMISSION FORM ON FILE WITH URBAN MEDIA ARTS IN ORDER TO UTILIZE FACILITIES AND/OR EQUIPMENT OR TO VOLUNTEER. MEMBERS/VOLUNTEERS **UNDER THE AGE OF 13** ARE REQUIRED TO HAVE A PARENT/GUARDIAN WITH THEM DURING ALL FACILITY/EQUIPMENT USE TIMES AND TRAININGS. ALL MEMBERS/VOLUNTEERS, INCLUDING YOUTH, ARE RESPONSIBLE FOR THEIR OWN TRANSPORTATION TO AND FROM THEIR ACTIVITY.

### YOUTH AND PARENT(S)/GUARDIAN(S)

1. I, the undersigned, hereby represent that I have completed the Urban Media Arts course pertaining to the equipment I am checking out/using, or have proven proficiency with said equipment.
2. I will return all equipment in good working order, normal wear and tear excluded, at specified time and date.
3. I understand that I am liable for loss or damage to any equipment and liable for my actions while using equipment, whether checked out or used within an UMA facility, and will report any problems or trouble with the equipment I am using to the UMA staff.
4. I understand that the use of the equipment I am checking out/using **MUST result in programming for one of the PEG access channels or Podcast channel that UMA provides.**
5. I also understand that the use of this equipment for profit-making, revenue-generating or **personal use** is strictly prohibited.
